A. Class of consumers

Below TMBL summarises the class of consumers comprising the target market for the Your Way Plus Investor Home Loan based on the Product's key attributes and those consumers' likely objectives, financial situations and needs. TMBL has assessed that the Product, including its key attributes, are likely to be consistent with the objectives, financial situation and needs of the target market.

PRODUCT DESCRIPTION	
Product Description	An investment home loan that provides access to a competitive low variable rate option and/or fixed rate option (from one to five years), package benefits (including an offset facility) and discount rates and flexible features.
Key Attributes	<p>An investment home loan with the following key attributes:</p> <ul style="list-style-type: none">• the ability to use credit to purchase, improve or construct an investment property or to refinance an existing home loan or other personal purposes;• access to a variable rate option and/or a fixed rate option (from one to five years);• ability to choose between making principal and interest or interest only repayments (the interest only repayment method is subject to approval and available for a maximum period of 5 years);• 6 months to 30 years loan term;• ability to split loan between fixed and variable rate home loans;• ability to request for top-ups (any increase to the amount of credit is subject to lending criteria and does not have to be accepted by us);• offset facility available;• ability to make unlimited additional repayments without cost for variable rate option;• additional repayments capped at \$10,000 per year for fixed rate option;• redraw facility;• ability to have Third Party Guarantor to secure the loan (subject to approval); and• ability to fund construction on a residential property.

Class Description	The Product has been designed for consumers who are seeking to purchase, improve, construct or unlock equity in property used or to be used for investment, business or other commercial purposes or to refinance an existing investor home loan and want a competitively low variable rate and/or fixed rate (from one to five years), package benefits (including access to an offset facility) and discount rates and flexible features.
Likely Financial Situation	<p>Consumers who:</p> <ul style="list-style-type: none"> meet TMBL's credit assessment requirements (which include the capacity to service the loan without substantial hardship); have access to regular income to meet repayments or a defined exit strategy; and where determined by TMBL to be required (including based on the member's deposit size and security), will pay Lenders Mortgage Insurance and/or have an acceptable guarantor.
Likely Needs	<p>Consumers who need credit to:</p> <ul style="list-style-type: none"> purchase a property to be used for investment, business or other commercial purposes; purchase vacant land for investment purposes; refinance an existing investor home loan; renovate or improve property used or to be used for investment, business or other commercial purposes; fund construction on property used or to be used for investment, business or other commercial purposes; or unlock equity in a property used or to be used for investment, business or other commercial purposes to finance the purchase of personal property.

<p>Likely Objective</p>	<p>Consumers seeking a credit contract with the following features:</p> <p>Ability to:</p> <ul style="list-style-type: none"> • save interest while having access to money by using an offset facility; • switch the repayment type from principal and interest to interest only (for up to 5 years and subject to approval); • switch the loan type from a variable rate to a fixed rate (from one to five years); • split the loan balance into fixed and variable rate home loans; • top-up the loan amount (subject to credit assessment requirements); • make unlimited additional repayments for variable rate option; • make additional repayments capped at \$10,000 per anniversary year for fixed rate option; • access a redraw facility (not available while loan is part funded during construction); • make flexible weekly, fortnightly or monthly repayments (interest only repayments are monthly only); and • access internet banking, mobile app banking and banking in branch.
